Ticket holders who purchased July Weekend Camping to the 2019 Quaker State 400 Monster Energy NASCAR Cup Series race before October 8, 2018 at 12:00AM EDT will be automatically entered
- By printing your name, complete address, daytime phone number, valid e-mail address and age on a 3 1/2" x 5" card.
